

Health, Safety and Environment Policy

FLSmidth is the full flowsheet technology and service supplier to the global mining and cement industries. We help our customers to improve performance, lower operating costs and reduce environmental impact. In mining, we provide the complete technology portfolio for process plants for key commodities, including copper, gold, nickel, lithium, zinc and iron ore. In cement, we provide the core products for the production of green cement.

Sustainability is a key focus area of FLSmidth's business strategy, creating a solid foundation for achieving excellence within environmental, social and governance (ESG) performance. Health, safety and environment (HSE) is not only an important element of ESG, but also a core element of our success, contributing significantly to our ability to be a responsible corporate citizen and an attractive proposition to investors, regulators and employees.

We are committed to achieving zero harm to our people, subcontractors, the communities in which we operate, and to our surroundings and the environment. Our duty of care encompasses both physical safety and personal well-being, and we offer various mental health and stress management programmes to help improve the quality of life for our employees and ensure a productive, healthy workplace.

Environmental management activities focus on reducing emissions, waste production and water consumption. Circular economy principles guide our waste reduction activities, including more reuse, recycling, repairs, remanufacturing and leasing.

Our HSE organisation supports our business lines and manufacturing organisation in line with the business strategy and structure. Supporting this are our robust HSE management system and objectives, which enable us to continuously monitor and improve performance.
